2021 3M PLAY TO WIN AWARD CONTEST RULES

NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE DOES NOT INCREASE THE CHANCES OF WINNING.

- 1. Eligibility: The 2021 3M Play to Win Award (the "Campaign") is open to student-athletes entering grades five through twelfth grade during the 2021-21 school year who live in the greater Washington-Baltimore metropolitan area and demonstrate the following (i) passionate about sports and displays team spirit, (ii) a potential qualities: demonstrated strong interest in STEM (science, technology, engineering and mathematics), social justice and/or racial equality, (iii) has a relative who either serves or has served in the military (the "Student"). A Student may be nominated according to the procedure set forth in these Contest Rules, and if selected as the Winner, (a) the winning Student; (b) one parent or legal guardian of the Student (the "Parent"); and (c) the person who nominated the Student for the Campaign (if not the student-athlete's parent or legal guardian) (the "Nominator") (Student, Parent and Nominator will be referred to collectively as the "Contestants") will be awarded the prize(s) set forth in these Contest Rules. The Campaign is only open to legal residents of the United States and is void where prohibited by law. Employees of the Military Bowl Foundation, Inc., 3M Company ("3M"), and each of their respective affiliates and subsidiaries, (collectively the "Employees"), and immediate family members and/or those living in the same household of Employees are not eligible to participate in the Campaign. The Campaign is subject to all applicable federal, state, and local laws and regulations. Void where prohibited.
- 2. Agreement to Rules: By participating, each Contestant agrees to be fully and unconditionally bound by these Rules, and each Contestant represents and warrants that Contestant meets the eligibility requirements. The entry must fulfill all Campaign requirements, as specified, to be eligible to win a prize. Entries that are incomplete or do not adhere to the rules or specifications may be disqualified at the sole discretion of the Military Bowl Foundation, Inc. and 3M. - A. Grand Prize: One student will be chosen to win the Grand Prize. The Grand Prize winning Student along with that Student's Parent and Nominator will each receive (a) receive a prize pack of items solely determined by the Military Bowl Foundation, Inc. and 3M. Fair market value of Grand Prize to Student is approximately \$500.
- C. No cash or other prize substitution shall be permitted except at the discretion of the Military Bowl Foundation, Inc. and 3M. The prize is nontransferable. Any and all prize-related expenses, including without limitation any and all federal, state, and/or local taxes, shall be the sole responsibility of the winning Contestants. No substitution of prize or transfer/assignment of prize to others or request for the cash equivalent by the winning Contestant is permitted. Acceptance of prize constitutes permission for the Military Bowl Foundation, Inc. and 3M to use the Grand Prize winning Student's name, likeness and entry for purposes of advertising and trade without further compensation, unless prohibited by law.

- 9. Terms & Conditions: Military Bowl Foundation, Inc. and 3M reserve the right, in their sole discretion, to cancel, terminate, modify or suspend the Campaign should virus, bug, non-authorized human intervention, fraud, or other cause beyond Military Bowl

Foundation, Inc. and 3M's control to corrupt or affect the administration, security, fairness, or proper conduct of the Campaign. In such case, Military Bowl Foundation, Inc. and 3M may select the winners from all eligible entries received prior to and/or after (if appropriate) the action taken by Military Bowl Foundation, Inc. and 3M. Military Bowl Foundation, Inc. and 3M reserve the right, in their sole discretion, to disqualify any individual who tampers or attempts to tamper with the entry process or the operation of the Campaign or website or violates these Terms & Conditions. Military Bowl Foundation, Inc. and 3M have the right, in their sole discretion, to maintain the integrity of the Campaign, to void nominations for any reason, including, but not limited to: multiple entries from the same user from different IP addresses; multiple entries from the same computer in excess of that allowed by Campaign rules; or the use of bots, macros, scripts, or other technical means for entering.
